All employees, collaborators, and partners are required to comply with environmental principles. Individual and collective environmental performance will be periodically evaluated.

- Responsibly using natural and energy resources, reducing waste and encouraging the use of renewable sources;
- Reducing waste generated by business processes;
- Preventing accidental events and safeguarding health;
- Properly managing chemicals and any hazardous waste, in compliance with regulations and minimizing their impact;

- Protect biodiversity and promote the regeneration of local ecosystems where possible;
- Monitor energy, water, and raw material consumption;
- Define and monitor measurable environmental objectives annually, with quantitative targets and verifiable timelines;

The environmental segment of the Ecovadis assessment is used to monitor progress and achievement of objectives.

#### 5. Environmental Risk Management

L'Aprochimide S.r.l. has developed an Environmental Risk Matrix, which considers:

- soil and water pollution risk;
- · air emissions risk;
- noise pollution risk;
- fire/explosion risk;
- energy consumption/low efficiency risk;
- biodiversity impact risk.

#### 6. Supply Chain Involvement

L'Aprochimide S.r.l. integrates environmental criteria into supplier selection, evaluation, and monitoring. Sustainable practices are promoted through:

- Request for adherence to environmental codes of conduct or standards (e.g. ISO 14001);
- Annual environmental assessments;
- Environmental audits for critical or high-risk suppliers.

#### 7. Monitoring, Audit, and Improvement Mechanisms

This Policy is reviewed in the event of significant regulatory, technological, or organizational changes.
